# Deal in works: Uddhav CM for 5 yrs, deputies from Congress & NCP

PRADEEP KAUSHAL New Delhi, November 18

WHILE NCP CHIEF Sharad Pawar insisted that he did not discuss government formation in Maharashtra during a meeting on Monday with Congress president Sonia Gandhi, sources told *The* Indian Express that an understanding has already been reached for a three-party ruling coalition to take charge of the state early next month with Shiv Sena chief Uddhav Thackeray at the helm.

If all goes according to plan, sources said, the new formation will have two deputy chief ministers — one each from the be chief minister for the full five-year term, with no rotation policy for the post. The 42 portfolios will be shared according to the strength of the three parties in the new Assembly, sources said. The Sena has 56 seats in the 288member House followed by NCP (54) and Congress with (44) — the portfolio split could likely be 15, 14 and 13 in that order. Sources said the Sena has left it to the Congress and NCP to decide on the post of Speaker with the name of Congress leader and former chief minister Prithviraj Chavan doing the rounds. The tentative understanding has been worked out by Pawar who, sources said, was the "moving spirit" behind the efforts underway to prop up a non-BJP

government. The NCP chief, however, kept his cards close to his chest while speaking to reporters after his meeting with Sonia Gandhi.

"Sharad Pawar met the Congress President today and briefed her on the situation in Maharashtra. It was decided that in a day or two, representatives from NCP and Congress will meet in Delhi to discuss the way forward," Congress spokesperson Randeep Surjewala said in a tweet.

Sources, however, said that with an understanding already reached, the series of meetings that are being held within and among the three parties is part of an effort to build consensus and momentum for a new formation, especially with the Shiv Sena having fought elections with the BJP.

Uddhav is expected to visit Delhi this week. But sources said he has deferred his proposed visit on November 24 to "We have discussed in Ayodhya as it would not be in NCP and Congress. They were detail the political situation in sync with the politics of his

During discussions to reach the understanding, sources said, Sena's Thane strongman Eknath Shinde was in contention for the top job. Shinde had been earlier elected leader of the Shiv Sena Legislature Party. The names of Sena leader Subhash Desai and Uddhav's son Aditya Thackeray had also gained circulation.

However, sources said, Pawar was clear that Uddhav would need to be at the helm to give heft and credibility to the arrangement. Desai and Shinde did not inspire confidence among the coalition partners, while Aditya was considered too young to preside over a government that would include senior leaders such as Ajit Pawar and Chhaggan Bhujbal.

## Chidambaram moves SC for bail in INX Media PMLA case; ED in HC over 'inadvertent error' in verdict

PRESS TRUST OF INDIA New Delhi, November 18

MINUTES AFTER SENIOR Congress leader P Chidambaram moved the Supreme Court on Monday seeking bail in the INX Media money laundering case, the ED approached the Delhi High Court seeking rectification of an "inadvertent" error in the November 15 verdict denying him the relief.

Chidambaram approached the apex court challenging the judgement of the Delhi High Court denying him bail in the money laundering case lodged by the Enforcement Directorate (ED).

Later, the ED moved the high court with an application urging the court to correct the "accidental slip/inadvertent error"in its November 15 verdict passed by Justice Suresh Kait who had denied bail to the 74-year old former finance minister.

As per ED's application, Jus-

referred to four paragraphs from a 2017 Supreme Court order rejecting bail to Delhi-based lawyer Rohit Tandon in a money laundering case

in his November 15 verdict. Tandon, who

was arrested in 2016, is an accused in the demonetisationrelated money laundering case.

The ED said:"... it appears that the said factual portion of the (Tandon) judgment relied by the ED instead of being quoted or summarised as the part of the relied upon judgment, has been inadver-



tently/accidently referred to in the order dated November 15 as the factual submissions made by the ED."

The Delhi High Court clari-

fied that the facts of another

case mentioned in the order denying bail to Chidambaram are only for reference. The court's clarification came while taking up the matter suo motu (on its own)

following news articles that

there is 'cut and paste' work in the judgement. In the apex court, Chidambaram's petition was mentioned before a bench headed by Chief Justice of India SA Bobde where senior advocate Kapil Sibal, appearing for the

senior Congress leader, sought urgent listing of the plea. Sibal told the bench, also comprising justices BR Gavai and Surya Kant, that Chidambaram has been in jail for

around 90 days. "We will see," the bench told Sibal, adding that the bail plea

would come up for hearing either on Tuesday or Wednesday. The Delhi High Court had

on November 15 dismissed Chidambaram's bail plea in the case filed by the ED, saying prima facie allegations against him are serious in nature and he played an "active and key role" in the offence. Chidambaram was first

arrested by the Central Bureau of Investigation (CBI) on August 21 in the INX Media corruption case and was granted bail by the Supreme Court on October 22.

मुंबई , 18 नवंबर (भाषा)

जियोजित फाइनेंशियल र्सिवसेज के अनुसंधान प्रमुख विनोद नायर ने कहा- ऐसा लगता है कि कंपनियों के दूसरी तिमाही नतीजों आने के बाद और इस हफ्ते प्रमुख आंकडे जारी नहीं होने से बाजार उतार - चढाव भरे दौर में जाता दिख रहा है। वैश्विक स्तर पर , निवेशक अमेरिका -चीन व्यापार तनाव के समाधान की दिशा में महत्त्वपूर्ण कदम का इंतजार कर रहे हैं। इसके अलावा , ब्याज दरों को लेकर अमेरिका के केंद्रीय बैंक के भविष्य के रुख पर भी नजर रखी जा रही है।
